Maximizing Mapping Resources at the Colorado Division of Wildlife

This article by Division employees Michelle Cowardin and Michelle Flenner describes an interactive mapping method created by Colorado Division of Wildlife's GIS group that speeds the process of capturing species distribution data in the field and digitizing it quickly. This new mapping method is a real-time, stand-up digitizing system that is portable and easy to use. The article reports that, "The process integrates ESRI Inc.'s ArcGIS software and a

SMART Technologies Inc. SMART Board interactive whiteboard system, allowing GIS and field personnel to work together as a team to successfully capture spatial data. Field personnel edit/enter map features directly into a GIS by simply drawing on base maps projected onto the interactive whiteboard. With the assistance of the GIS specialist, there's no need for the field personnel to have prior GIS experience. Supporting map layers can be panned, zoomed and queried to assist the managers as they draw habitat boundaries on the whiteboard."

National Water-Quality Assessment (NAWQA) Data Warehouse

This Web site provides online access to 8 million records of water-quality information and is aimed at water-resource managers, scientists, and the public who may seek data about the quality of water or chemical concentrations in aquatic tissue at 4,100 stream sites and 6,500 wells across the United States. In March 2003, data on fish communities became available for 960 stream sites in more than 50 major river basins across the Nation. Data is available for download on more than 1,900 fish community samples that were collected from 1993 through 2002 by the National Water-Quality Assessment Program. USGS fish community samples document the presence of all fish species and their relative abundances within designated stream reaches. Protocols used for the fish sampling are described in a document linked from the web site called *Revised protocols for sampling algal, invertebrate, and fish communities as part of the National Water-Quality Assessment Program* at
